- 5. Complete and sign the Commercial Natural Gas Savings Program application. For insulation projects, the beginning and ending R-value must be indicated.
- 6. Attach originals or legible copies of the following:
  - Invoice from contractor or receipt for materials purchased.
  - Contractor invoice should include: invoice date; invoice number; name and address of contractor; address where work
    was performed; linear footage insulated; R-value of insulation installed; brand, model number, and AFUE or energy factor
    of equipment installed; total price.
  - Current NorthWestern Energy bill for address where work was performed.
- 7. Submit completed application along with all documentation and current NorthWestern Energy bill.
